

NORTHWEST UNITED FC TUITION AND TEAM FEE AGREEMENT PLAYER/PARENT CONDUCT AGREEMENT



This Agreement represents a contract between the Player/Parent and Northwest United FC ("NWU"). As the Player is a minor, the Player's parent is a necessary party to this Agreement and is acting on behalf of the Player. This Agreement outlines the Parent's agreement and consent with respect to the payment of NWU fees and Team fees, acknowledgement of the "No Pay, No Play" policy, the Parent's conduct, and the Player's conduct related to all NWU activities.

NWU Tuition and Team Fees

As a Parent, I hereby agree as follows:

1. I will pay NWU Club Tuition directly to Northwest United FC (PO Box 2120, Mount Vernon, WA 98273) or pursuant to an otherwise agreed upon electronic payment plan. I recognize there are two different payment options for NWU Club Tuition. The first option is to send a check to the Northwest United FC address referenced above. The second option is to pay online to NWU.
2. I agree to pay the NWU club tuition amount published at the end of this registration, which covers all NWU fees from May 1 through April 30. The Tuition does not include additional Team Fees and Uniforms.
3. I agree to pay first installment at registration before being placed on a team. After registration, the remaining portion of the NWU Tuition shall be paid in eight equal installments over the subsequent eight months. A monthly payment must be received by the last day of each month.
4. I recognize that if I fail to pay the NWU Tuition on the monthly schedule referenced above, the Player will not be allowed to play in games or in trainings until the unpaid portion of the NWU Tuition is paid in full or brought up to date; provided however, that the Parent and any member of the NWU Executive Committee or the NWU Administrator can reach an alternative agreement regarding the payment plan outlined under this section of the Agreement. Such alternative agreement must be agreed to in writing or via email correspondence with such parties.
5. I further agree and recognize that, per the Northwest United "No Pay, No Play" Policy, if NWU Tuition and/or Team Fees have not been paid and no alternative arrangements have been made with NWU, the Player's coach will be notified that the Player will not be able to play in matches or trainings until such unpaid fees are paid.

Parent Conduct Agreement

1. I agree to support all players by being positive before, during, and after team matches and other team events.
2. I agree not to coach or direct players in trainings or matches.
3. I will not communicate with the officials or opponents at matches.
4. I agree to make sure that Player is ready to play; including eating well, sleeping well, equipped with proper equipment, and will do my best to make sure the Player is having fun and maintaining a proper perspective for the sport.
5. I will participate in team events to the best of my ability, including team fundraisers, helping with transportation, participating in other team events and supporting all of the players on the team in their efforts.
6. I am encouraged to communicate with the coach regarding player development, playing time, personality issues, etc., at times other than trainings or matches.
7. I understand that I am expected to support NWU by volunteering for the Player's team and attending NWU activities whenever possible.

Player Conduct Agreement

1. Player shall at all times compose himself/herself and interact with respect toward his/her teammates, coaches, officials, sidelines and opponents.
2. Player shall attend trainings and matches ready to play, well-fed, rested, with appropriate hydration, equipment and a good attitude.
3. Player shall take responsibility of communicating positively with coaches regarding absences, tardiness, injuries, field position, etc.
4. Player will commit to working hard, striving to improve Player's game, and having fun.
5. Player will obtain and provide written medical clearance where illness and/or injury have resulted in a doctor or hospital visit.
6. Player shall commit to the team for the entire season. If unforeseen difficulties occur, the Player will inform the coach in a timely manner.

The Parent and the Player (through the Parent's consent below), hereby agree and consent to the foregoing fee and conduct terms.
